<u>Treasurer's Report</u>: Beginning Balances-General Fund \$636,630.45 ARPA Fund \$29,955.06 Ending Balances - General Fund \$201,896.01, ARPA Fund \$23,963.56 **Motion** Knapp 2nd Frandsen to approve the Treasurer's report as presented. Motion passed unanimously

Reading of the Bills: Ck # 9415 - #9535, (plus online/CC payments) Totaling: \$425,017.24 Motion Frandsen 2nd Thornhill to pay bills as presented. Yes: Knapp, Frandsen, Podell, Thornhill & Boes Nays: None Motion passed. The treasurer explained that she moved \$400,000 from the General Checking account into a Money Market account to increase interest our money can earn.

Report from Zoning Administrator – Dave Kelsey: No permits were issued for December 2023 **Report from Fire Board:** 3 incidents in MVT, FEMA Grant for air compressor to Trufant station, Treasurer has requested a copy of the Annual Audit of the Fire District for our records. **Report from Cemetery Coordinator**: Working on the maps with CIMS, no burials & will be accepting bid for lawn service & sexton work.

Old Business:

A. Parks Update – Treasurer Brewer presented a map with the properties associated with "Petersen Park" in Trufant. Township Attorney is drawing up a new deed for both parties, that currently own Petersen Park, to sign for the Township to officially own the "leased" property of Petersen Park. The properties are still being surveyed, but waiting for title searches to ensure the property boundaries are correct. Veteran's Park in Trufant is essentially 80' of a side yard that was "leased" to the Township to put a monument & flag pole – it is not a separate piece of property and never can be split from the home that resides on the property. The board discussed the future of the park and agreed that once all the Township properties are surveyed and we know exactly what is owned by the Township then the location of the Veteran's Park will be reviewed to establish where it can be moved & improved upon. Coral Park – part of the park is on the Church property and a property line adjustment has been proposed to the owner of the church. to We are waiting to see if this is agreeable and how much money they would like for the portion of property that the park is occupying.
